In 2022, The Haven of Transylvania County provided shelter to 85 people, including 21  
children and 11 families that were experiencing homelessness and lacking resources to  
obtain housing on their own. Facilities provided by The Haven include kitchens,  
showers, laundry, mail, and messaging service. Clients receive case management and  
mental health counseling, as well as other specialized programs to help them stabilize  
and prepare them to sustain themselves after they are housed. 57% of guests last year  
moved into permanent housing.
